- EMD (Earnest Money Deposit): EMD is Rs 15,000/- (Fifteen Thousand). EMD value should be submitted along with commercial bid by the way of Demand Draft in favour of The Administrator, The Chandigarh State Co-operative Bank Ltd.; payable at Chandigarh.
- Bidders are advised to study the Request for Proposal Document carefully.
   Submission of Proposal shall be deemed to have been done after careful study and examination of the Request for Proposal Document with full understanding of its implications.
- 4. The document may be deposited in the Head Office of The Chandigarh State Coop bank Ltd., Chandigarh. Bids received after 04:00 PM on 16.12.2019 will not be accepted or considered under any circumstances. In this regard decision of the Bank shall be final and no request in this regard will be entertained. Bid must be submitted in sealed envelope along with Technical and Commercial proposal.
- 5. The financial bid should be valid for a period of not less than 90 days from the date of opening of bid.
- 6. Bidder should be authorized dealer/ Partner / distributor of Microsoft in India.
- 7. The Bid Document is to be downloaded from the Website (<a href="www.cscbapex.com">www.cscbapex.com</a>). Downloaded document must be deposited before the last date & time.
- 8. The Chandigarh State Cooperative Bank reserves the right to accept or reject in part or full any or all the offers without assigning any reasons there for.
- 9. All the pages of Bid including Brochures should be made in an organized, structured, and neat manner. All the pages of the bid should be initiated with Name, Seal and Signature of the Authorized Signatory. Signing on all pages of RFP will be treated as a confirmation of offer of having accepted the conditions.

#### 10. EVALUATION OF BIDS

- a. The Bidders complying all the pre-qualification of Technicality as submitted in the Technical BID will be considered eligible for consideration of Financial BID.
- b. The Financial Bid will be opened only for Bidders successful in the Technical Bid.
- c. The Lowest Commercial (LC) will be determined on the basis of the lowest price quoted in the Financial Bid by the eligible bidders.
- 11. Please note that all the information desired needs to be provided. Incomplete information may lead to non-selection.
- 12. Payment will be released after receipt of Microsoft Office license as certified by concerned branch/section.
- 13. Validity of Microsoft Office license must be lifetime.
- 14. The License should be valid and legal to use for banking business/activity etc.

1.	Bidder should be authorized dealer/ Partner / distributor of Microsoft in India.	A letter of authorization from Microsoft should be submitted.

3.	The Bidder should not have been blacklisted / debarred by the Government of India or their undertakings, any State Governments or their undertakings previously. 4.	Experience in dealing with Govt. Department	Attach copies of supply placed to the department.	
5.	Photocopies of relevant documents / certificates, duly stamped and signed must be submitted as proof in support of the claims made. The Bank reserves the right to verify /evaluate the claims made by the Bidder independently. The decision of the Bank in this regard shall be final, conclusive and binding upon the Bidder.
